## **THE NEW LANDSCAPE OF CYBERJUSTICE: INFORMATION, REGULATION, AND DEMOCRACY**

Researchers, experts, and professionals from a variety of countries will meet at the Cyberjustice Europe Conference 2023, the second of its kind to be organized by the Council of Europe, Paris's *Institut des études et de la recherche sur le droit et la justice* (IERDJ) (Institute for Studies and Research on Law and Justice), Montreal's Cyberjustice Laboratory, and the University of Strasbourg. Over the course of one day, the members of this diverse international community will discuss the impact of technology on justice policies and practices and seek to answer questions relating to regulation of artificial intelligence, evolutions in cybercrime, the need for public policies to support the development of online platforms and services, the impact of expanding access to legal and judicial information, augmented lawyering, and the virtual future of hearings. The Conference will conclude by addressing whether technological progress is still a friend of democracy.
